## PLEASE NOTE:

**Lunch Program:** It is not an option to reduce the tuition by opting out of the lunch program. The cost is included in the tuition schedule. Special requirements for allergies, dietary health issues, or religious beliefs will be accommodated.

**Materials Fee:** A \$200 materials fee is due with your first tuition payment. This fee covers all books and materials for classroom use.

**Early Drop Off/Stay & Play Program:** If Pre-School early drop off or stay & play care is needed there is an additional charge for that service.

**Field Trips:** The BSDA will be taking students on local/Big Sky field trips throughout the year – this is included in the tuition. However, there may be special trips outside of the local area that may require additional costs. Parents will be given advance notice of these excursions to prepare for any added expense.

**Ski Season:** Ski passes for Big Sky Resort will be included for the 2017-18 season. This does **not** include ski instruction programs (BSSEF - YSL, Buddy Werner, etc.).

**Delinquent Accounts: Payments are due by the 1<sup>st</sup> day of each month. A \$25 late fee will be imposed.**

All returned checks will result in a \$50.00 service fee. Accounts will be considered unpaid until tuition payment, late fees, and returned check fees are paid.

Parents/Guardians are responsible for tuition and other fees regardless of illness or other absences from school (i.e., vacations/trips). Enrollment is for the full school year. The school is an independent, non-profit organization. A thirty (30) day written notice is required before withdrawing a child from the BSDA. Tuition and fees are non-refundable.

When this Enrollment & Tuition Contract has been signed, your child will be enrolled on a **6-week trial basis** commencing their first day of attending school. If necessary, a parent/teacher conference(s) will be held during this trial period to review your child's progress and to determine how to best meet the needs of your child. Should BSDA/parent(s) be unable to harmoniously remedy the student's ability or willingness to maintain a reasonable level of performance in the school at the end of the 6-week trial period, the student's enrollment will be terminated. If payment for the full tuition year has been made, reimbursement for no more than 7 months may be refundable.
